COURT GEOGRAPHICAL COVERAGE

Rocky River Municipal Court serves five West Shore communities (Rocky River, Bay Village, Fairview Park, North Olmsted and Westlake) and is the level of Ohio's judicial system. The court is located at 21012 Hilliard Blvd., Rocky River, Ohio 44116 and has an informational website at rrcourt.net. The court plays a vital role in the local justice system, ensuring the fair enforcement of laws and the resolution of disputes.

LEGAL RESPONSIBILITIES

Municipal courts have several key responsibilities:

- **Misdemeanor Criminal Cases**: They handle misdemeanor offenses such as petty theft, and disorderly conduct.
- Civil Cases involve claims up to \$15,000.
- Small Claims with disputes not exceeding \$6,000.
- Traffic Violations: They address traffic-related offenses.
- **Probation Services**: They provide probation and other community-based services to support rehabilitation.
- Mediation Services: They offer mediation to help resolve disputes outside of court.

The key personnel responsible for the court's operation are the municipal court judges and the clerk of courts.

RESPONSIBLITIES OF COURT JUDGES

Rocky River Municipal Court has two judges (Presiding Judge Brian Hagan, Judge Joseph Burke) elected every six years by the voters of the five suburbs. The judges' responsibilities include:

- Presiding Over misdemeanor criminal cases, civil cases, and small claims cases.
- Ensuring Fair Trials in accordance with the law.
- Issuing Rulings on motions, evidence, and the final verdicts in cases.
- **Sentencing**: Judges determine appropriate sentences for convicted individuals, including fines, community service, or jail time.
- Administrative Duties: manage court schedules, oversee court staff, and ensure the efficient operation of the court.

These responsibilities are crucial for maintaining justice and public safety within the West Shore communities.

RESPONSIBLITIES OF CLERK OF COURT

The efficient operation of the court is maintained by municipal court clerks and their staffs. The key responsibilities of clerks include:

- Maintaining All Court Records, including case files, judgments, and orders.
- Filing Legal Documents and Maintaining the Court Docket by scheduling cases for hearings.
- **Assisting the Public** with information regarding court procedures, case statuses, and filing requirements.
- Collecting court fees, fines, and costs associated with legal proceedings.
- Issuing Summons and Subpoenas necessary for court proceedings.

Rocky River's Clerk of Courts is also elected every six years. The current clerk is Deborah Comery, who is assisted by appointed Deputy Clerk Holly Forsythe.

COURT ACTIVITY

Activity at Rocky River Municipal Court increased in 2024. The court dealt with over 15,100 incoming cases and had over 14,500 terminations.
